
1 MONTH NORMALISED % PERFORMANCE (USD)

 The Bloomberg Commodity Index reached 104.6 at the end of September, the index tracks 23 commodities.









5-YEAR JSE PERFORMANCE (ZAR)





5-YEAR JSE vs LEADING GLOBAL INDICATORS (USD)


