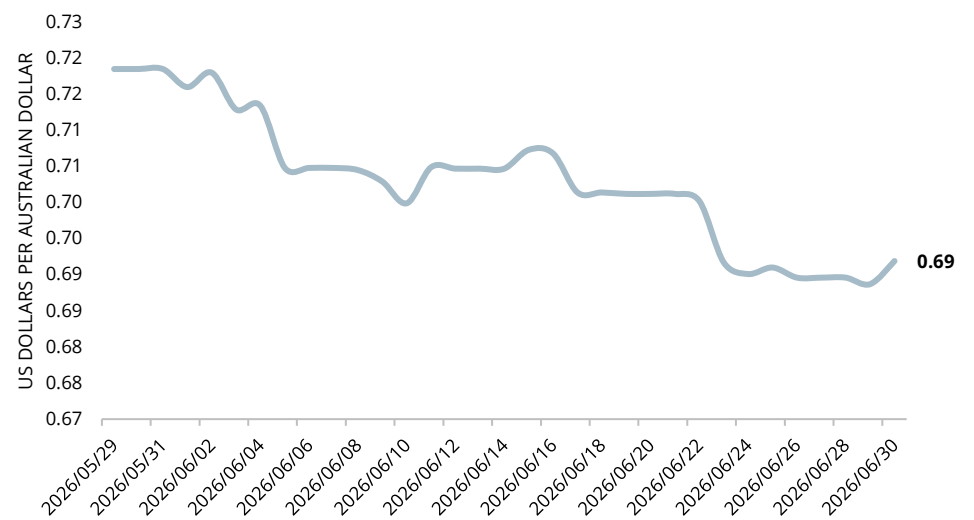
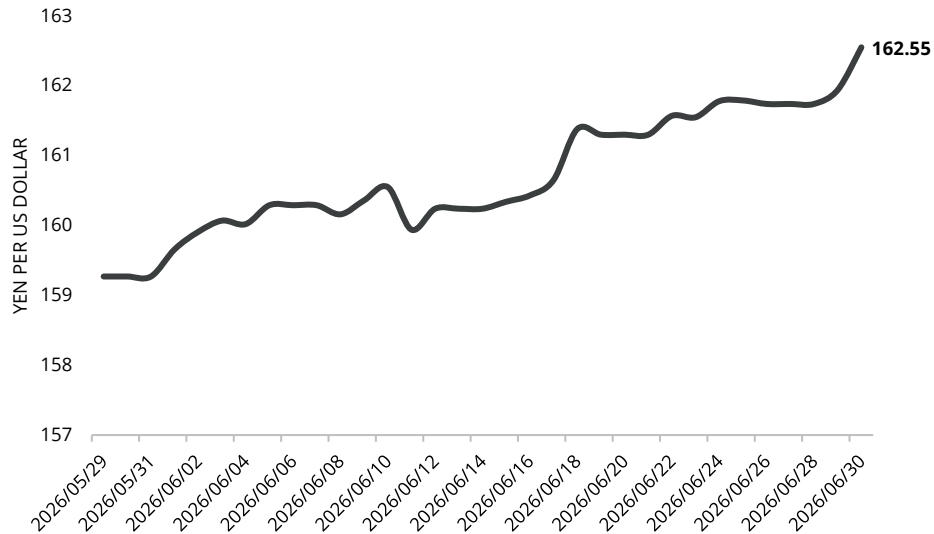
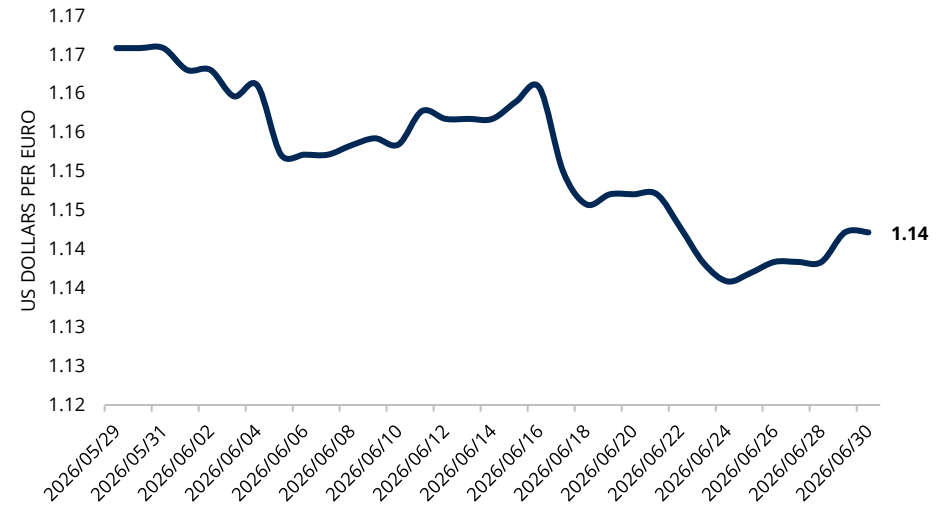
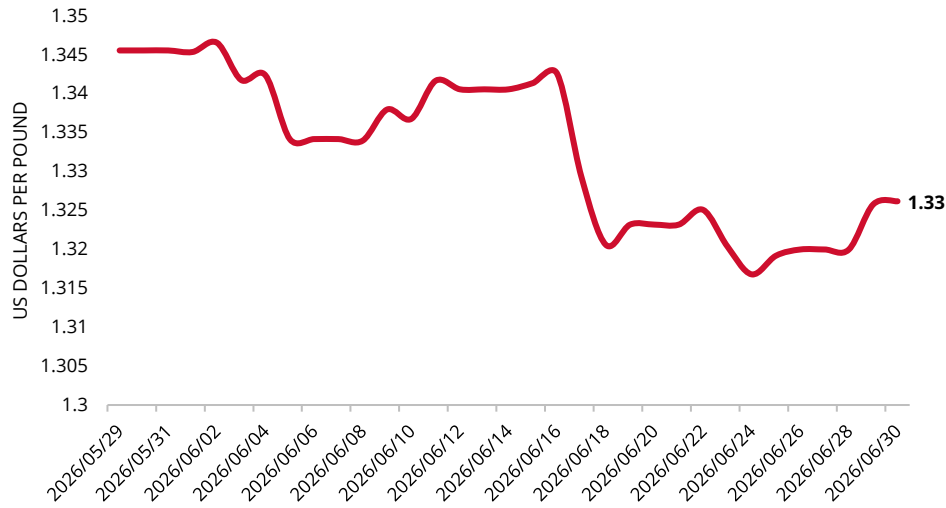
Monthly Review | 1 Month Normalised Performance (USD)

Commodities ended the month of June lower, with Copper and Platinum leading the losses.

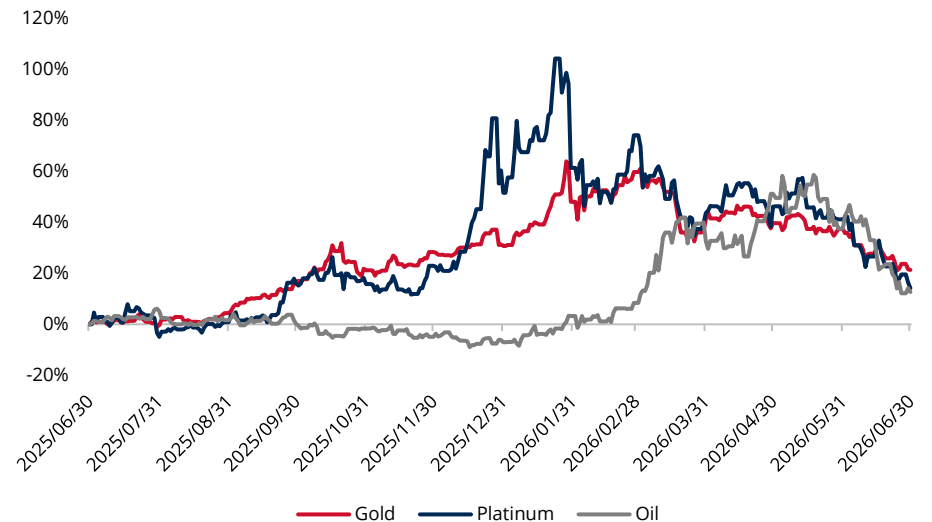

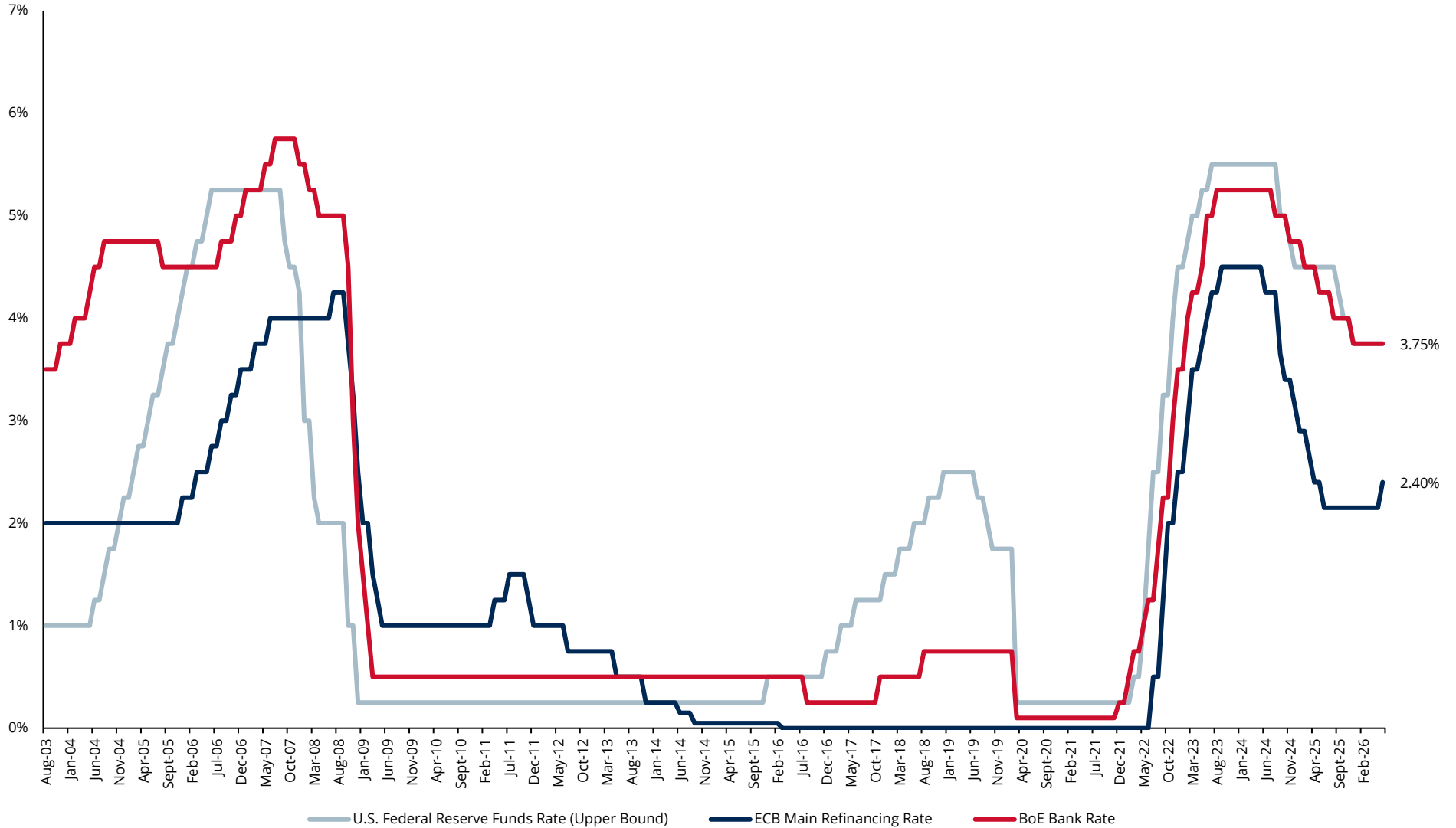

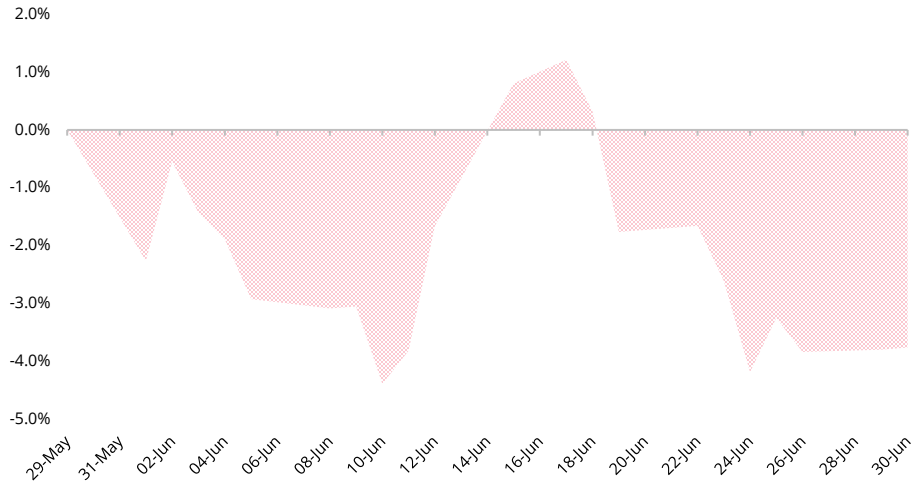
SA Markets | 5-Year JSE Performance (ZAR)



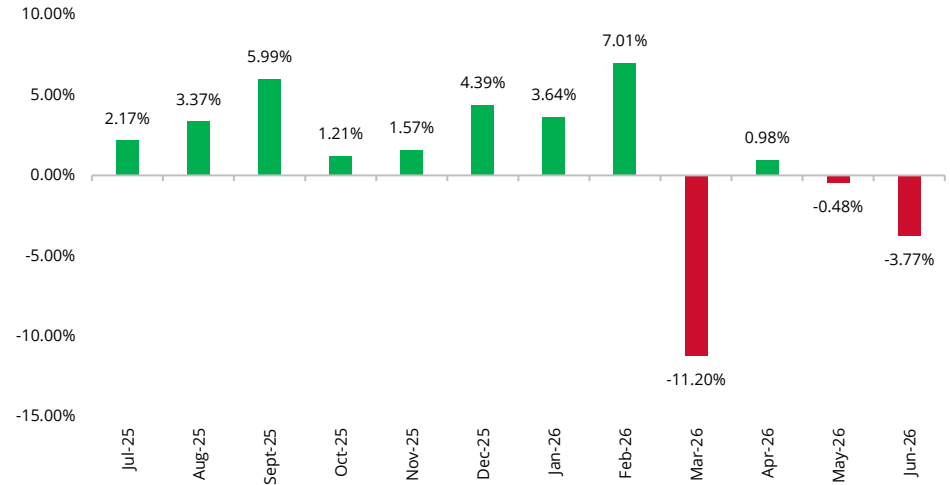
SA Markets | JSE All Share Index



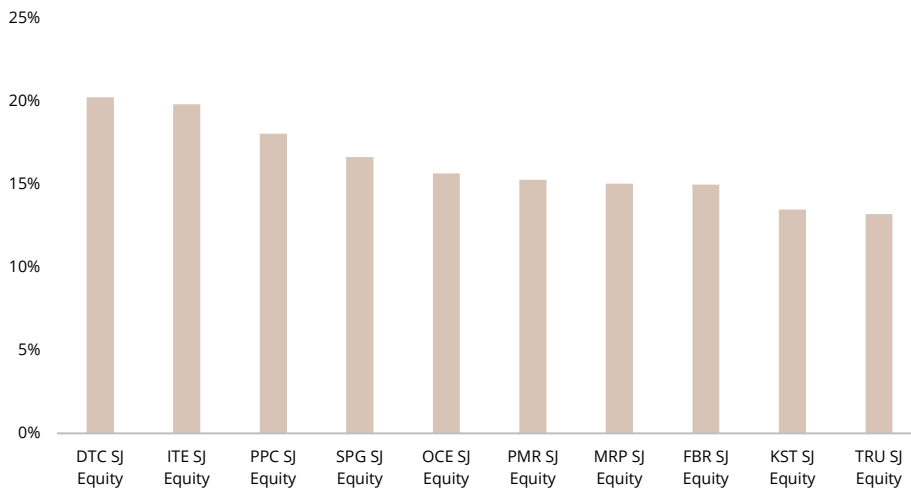
JSE All Share Index | Cumulative Performance



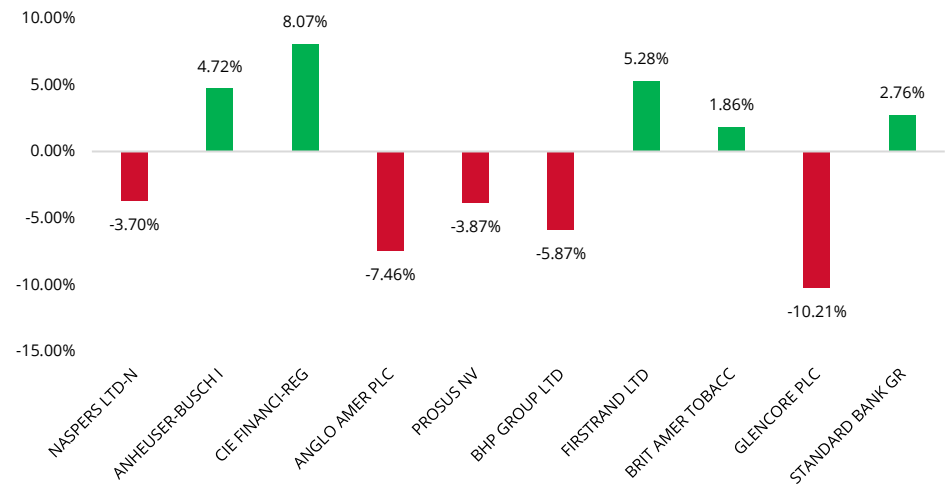
JSE All Share Index | Monthly Performance

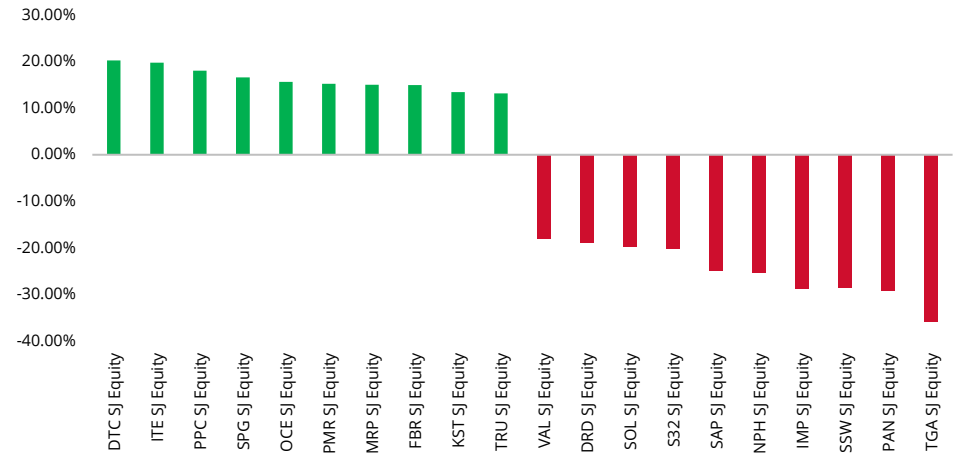

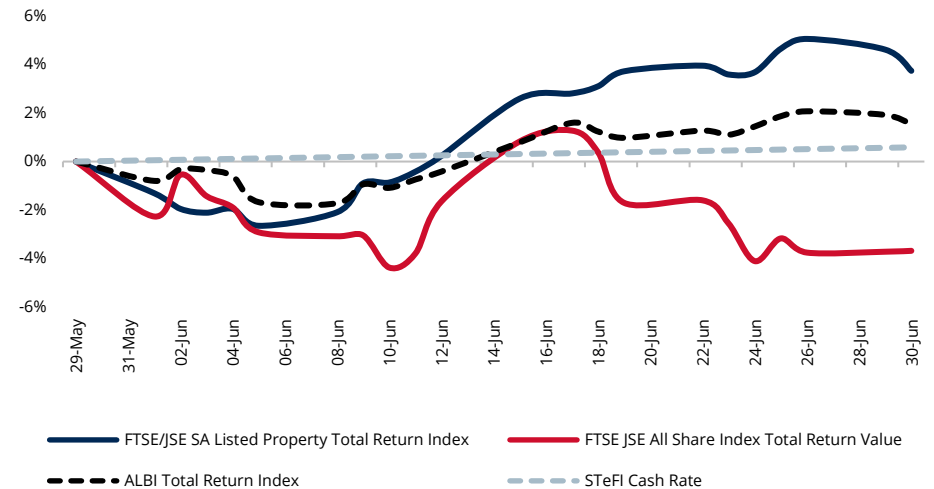
SA 10 Year Government Bond Yield
